# SITE REQUIREMENTS

Sites will be allocated 2 x Trade Passes valid for single entry only Additional passes can be purchased at \$10 each. FOOD VENDOR SITES: \$75.00 Depth allowed as per General Site

FRONTAGE 3m DEPTH x 3m - \$35.00

FRONTAGE 3m DEPTH x 6m- \$70.00

POWER Single Phase - \$15.00 per day per connection

### SITE HOLDER TERMS and CONDITIONS

- 1. The committee has the final right to accept or reject any application, all requests for refunds will be at the discretion of the committee and considered on a case-by-case situation. The committee will allocate sites, should a reposition of the site be requested, the committee have the right to make the final decision. Entry and Exit to the Showgrounds will be as directed by organisers.
- 2. Display of approved advertising signs of any description is restricted to the area occupied by the site holder. The committee shall have the power to enter upon the site allotted and remove any article, sign, picture, or printed information which in the Societies opinion may be a cause of offence to the public?
  Socially sensitive sites will not be accepted and there will be no exclusive trading rights agreements.
- 3. **ELECTRICAL LEADS FOR SITE:** Must be tested and have a current tag to meet the requirements of the Australian /New Zealand standard. AS/VZS 3002.2008 Electrical Installations for Shows & Carnivals. **POWER BOARDS:** Must be of approved external industrial quality.

- 4. **RESPONSIBILITIES:** The Ridgelands Show Society will not be responsible for any accident or incident that may be caused through or by any merchandise or food of site holders. It shall be a condition of approval that each site holder shall hold the Society blameless and indemnified against legal proceedings from such incidents or accidents.
- 5. SET UP, PULL DOWN, AND ACCESS:

SET UP of all sites MUST BE COMPLETED by 8.00 am on Saturday 1 June 2024.

All sites MUST REMAIN for the full day of the Show. **PULL DOWN** of stalls **MUST NOT START** until **4.30pm on Saturday 1 Jun 2024**. (Show is open from 8am to Midnight Saturday 1<sup>st</sup> June 2024)

- 6. **SITE BOUNDARY:** All tables, signs and products **MUST REMAIN INSIDE** the boundary of your site perimeter. (E.G. If you have a 6 x 3m site then **EVERYTHING** must be within that area of 6x3m.)
- 7. **BANNED ITEMS:** Any person/s found to be selling and/or in possession of, any items listed on the Banned Items List will have the items confiscated for the duration of the Show. If this is no adhered to they will be asked to leave the Showgrounds.

- 8. FIRE: Precautions will be taken to guard against fire and to protect the property at the Show, but site holders will NOT be insured at the cost of the Show Society.
- 9. All stallholders must abide by the relevant legislation relating to their product, service, or activity.
- 10. The selling of raffle tickets is prohibited by any stallholder, other than affiliated Show Society Members.
- 11. Site holders must dispose of their rubbish (not in Show Society bins). The Show is run by Volunteers please help us, by keeping your area clean and tidy.
- 12. Site holders are responsible for their own Public Liability Insurance. The Mt Larcom District Show Society will not be responsible for any costs of action bought against site holders. The organisers do not accept any liability for damage, loss, theft, or misuse of any goods brought to the showgrounds.
